WHAT IS UNITED WAY?

United Way of Greater St. Louis mobilizes the community with one goal in mind – helping people live their best possible lives. By supporting more than 160 local nonprofits, United Way doesn't help just one cause, but hundreds of causes through five key priority areas: basic needs, early childhood and youth success, health and wellbeing, jobs and financial mobility, and community stability and crisis response. United Way also manages the region's largest [volunteer center](#) and 2-1-1, a [free, 24-7 helpline](#) for the community.

WHO DOES UNITED WAY SERVE?

United Way partners with hundreds of nonprofits across a 16-county region: Calhoun, Clinton, Greene, Jersey, Macoupin, Madison, Monroe, Randolph and St. Clair counties in Illinois and Franklin, Jefferson, Lincoln, St. Charles, Warren and St. Louis counties, as well as the City of St. Louis in Missouri. The causes that United Way supports strengthen our community as a whole by helping children, adults, seniors, individuals and families.
